Our families like ShopWithScrip.com because they can securely order scrip any time day or night, from any internet-connected computer and check their rebate history at their convenience. Your initial temporary login information will come through email.



Families can also pay for their scrip online with **PrestoPay™**. **PrestoPay™** is NOT a credit card based system - it's better. **PrestoPay™** uses the safe, reliable NACHA electronic fund

transfer system. You enter your checking account information one time in a secure environment. After the account is verified, you can choose to have the order payments electronically deducted from your checking accounts and send/bring in payment when you order. The system is safe, secure and convenient!

The quickest way to get scrip is ScripNow! Purchase, pay with PrestoPay™ and print eCards from home, view using MyScripWallet on your smartphone, or enter the eCard code online to use scrip for shopping in minutes. Over 280 available brands available.

This agreement continues unless replaced by another, and can be terminated by either of us upon 60 day's advance notice to the other.
