TUITION ASSISTANCE DATA SHEET

St. Mary Parish is continuing its commitment to Catholic education in Kenosha by offering tuition assistance to parish families who will be sending their children to either St. Joseph Catholic Academy or All Saints Catholic School. This aid will be in addition to the scholarships St. Mary’s already awards each spring. The amounts granted under this program will be at the discretion of the Pastor and the Selection Committee in keeping with our current budget and will be used for tuition in the 2026/2027 school year. Families may apply for aid in successive years. Upon confirmation of the student’s registration for the coming year the awarded assistance will be made directly to the school on behalf of the student. The tuition assistance will be determined upon careful review of the applications received, along with the requested documents indicated below. Failure to provide the documents requested may be a basis for rejecting the application. The criteria to be used by the Pastor and the Selection Committee are as follows:

1. The family has been a registered, active member of St. Mary Parish for at least six months. Active membership requires faithful attendance at Mass on Sundays and Holy Days, regular support of the Parish through envelopes or direct withdrawal system, and participation in at least one Parish spiritual program, ministry, or organization.
2. Family financial need will be taken into consideration at the discretion of the Pastor and the Selection Committee.

The tuition assistance application is attached to this data sheet or can be obtained by contacting the St. Mary Parish Office or by reviewing the Parish’s website at www.stmarycatholic.org. To be considered for this assistance the attached Application, the family’s most recent federal and state tax returns and a written explanation of your financial need must be submitted to the St. Mary Parish Office [Attn: Amanda Feekes] by noon on Thursday, April 30th, 2026. TUITION ASSISTANCE INFORMATION

1. Upon determining an amount of tuition assistance, the recipient family will be notified of the grant and the amount as soon as possible by the Pastor or his designee.
2. Applicants not receiving assistance will be notified in writing of the parish's determination as soon as possible after the determination is made.
3. The tuition assistance aid will be forwarded to St. Joseph Catholic Academy or All Saints Catholic School on behalf of the recipient family as soon as practicable
