## What is Camp Covecrest?

Covecrest is a Life Teen summer camp for high school students in Tiger, GA (about two hours NE of Atlanta). Camp Covecrest is filled with many outdoor and adventurous activities including white water rafting, low ropes courses, an obstacle course, messy games, and so much more! Covecrest sits in the beautiful North Georgia mountains, surrounded by trees but equipped with a wide-open field perfect for games and star gazing unlike any other (sometimes the Milky Way can be seen). ## Practical Information about Covecrest

- We will be attending Week 8: July 18-23 at Life Teen's Camp Covecrest in Tiger, GA
- Camp Covecrest is open for teens who are currently in 8<sup>th</sup> grade to teens who are currently seniors in high school.
- We will depart from St. Mary's around 6am on July 18, 2022, and will return to St. Mary's around 9pm on July 23, 2022
  - o Times are an estimate and are subject to change, parents will be notified of the change and will be kept updated on arrival time back to Mobile
- Cost of the trip is currently \$660 plus travel costs (we will be taking a Gulf Coast Tours bus)
  - o This cost is subject to change dependent upon fundraising and donations
  - o If you would like part of the fundraising to be applied to your teens cost, your teen must help with and attend the fundraising events (more information on this will be given)
  - o If money is a concern, please contact Abigail Standish for other options
- A deposit of \$100 and the liability waiver are due by Dec. 1 in order to secure a spot
