

SAINT JOSEPH & CABRINI PARISH COUNCIL MINUTES

June 13, 2018

The June meeting was called to order by President, Paul Fritz, at 7:02 PM. Members present were Paul Fritz, Kelsey Rubey, Karen Morgan, Mike Adrian, Leonard Drish and Shirley VanDee. Additional guests present are Steve Pacha.

An opening prayer was recited by Shirley VanDee. Minutes of the May 9, 2018 meeting were read by Kelsey Rubey. Karen Morgan moved to approve the minutes. All seconded. Approved.

CHRISTIAN SERVICE/SOCIAL ACTION

Paul Fritz reports that Nancy Anderson called him and states she is still working on the library materials in the back of church. Shirley recognizes Carol Robinson for bringing Caryl Smith to church as well as to medical appointments and for also helping to take Carol Mottet to her medical appointments.

Shirley reports having set the green banners out in the sacristy and is requesting help to put them up at the altar. Paul Fritz states he will put them up.

MAINTENANCE

Mike Adrian reports having contacting Gavin Stacy in regards to the railing at St. Joseph's, but hasn't received a phone call back. Mike plans to contact him again to follow up.

Mike Adrian reports Jeff Ledger has been working this past week on the tile, down spout, and block on the north side of the church but isn't sure if the project is completed yet.

Shirley reports that Paul Fritz and Steve Pacha have fixed a hole in the county road on the south side of the church.

Shirley also reports that Kelly Farrier is doing a wonderful job of maintaining the lawn at St. Joseph. He also has been reporting that he is picking up sticks in the lawn. Shirley reports he has also been mowing the cemetery but doesn't know if he is planning to continue with this. Kelly has also made comment that he is planning to seed the stump holes once ready. Mike Adrian will contact Jeff Ledger about filling the stump holes with soil.

Leonard Drish questions if we could plant crown vetch on the bankside on the grater ditch on the west side of the church to help prevent mowing the ditch. Mike Adrian states a concern is getting it started growing.

Shirley reports the lights are out in the elevator and she found one bulb to replace a light but that the other still needs replaced.

FINANCE

Mike Adrian reports we are below budget for offertory and envelopes for May. We are still above the annual fiscal budget at this time. He projects approximately \$15,000 profit for the fiscal year. Mike reports typically having a break even. Shirley reports having put \$910.00 in the bank yesterday from the tractor ride.

ALTAR AND ROSARY

Shirley reports there are a lot of rolls left over from the tractor ride so we are planning to have coffee and rolls this Sunday for Father's Day. There were also plenty of cookies left over to freeze and furnish cookies for bible school on July 8th.

Altar and Rosary is still working on job duties for the bazaar.

Shirley and Suanne Dickey attended the "Rebuild" workshop. Shirley reports it was a very helpful workshop and felt as though the parish scored well on the checklist. Shirley reports a downfall of the parish is that we do not offer a religious education program and there are very few children attending church. Most of the children in the parish are juniors this year and will be leaving for college. This poses concern for mass servers down the road. Shirley questions if the council has suggestions of downfalls that need improvement. Paul Fritz states recruitment for parishioners.

ADDITIONAL COMMENTS

Karen Morgan reports she has moved to Keota and will be resigning from the Parish Council. Shirley questions how to go about filling the vacant parish council member spots. Mike Adrian suggests placing a note in the bulletin.

Leonard Drish also states the Ron Baker mentioned to him that he is wanting additional help with getting donations for the bazaar.

A closing prayer was read by all. Karen Morgan moves to adjourn the meeting. Leonard Drish seconded. The next meeting is Wednesday, July 11, 2018 at 7:00 P.M. at St. Joseph. Meeting adjourned at 8:10 P.M.
