SAINT JOSEPH & CABRINI PARISH COUNCIL MINUTES

May 8, 2019

The April meeting was called to order by President, Paul Fritz, at 7:02 PM. Members present are Paul Fritz, Kelsey Rubey, Mike Adrian, Jeff Ledger, Marsha Linnenkamp, Dennis Linnenkamp, Arlene Fritz, Amy Webber and Shirley VanDee. Leonard Drish is present as an additional guest.

An opening prayer is read by Shirley. Minutes of the April 10, 2019 meeting were read by Kelsey Rubey. Nancy Anderson moves to approve the minutes. Approved.

CHRISTIAN SERVICE/SOCIAL ACTION

Nancy Anderson reports having planned to set up a prayer chain. All of the parishioners on the prayer list are listed in the bulletin, so this replaces the prayer chain. Nancy encouraged parishioners to report anyone who needs to be on the prayer list to Shirley.

Shirley reports the cleanup at Gerald and Rosemary Pacha's went well.

FAMILY LIFE

Arlene Fritz reports planning to do something for parents of the new baby in the parish. She is open to suggestions but is thinking about putting together a meal to take over.

Shirley reports Caryl Smith wants to hold another congregate meal, however it has been voted down by Altar and Rosary twice as they don't believe it is serving the parish.

LITURGY

Shirley reports needing a committee to help with decorating the church.

MAINTENANCE

Paul Fritz states the elevator doors were "bouncing" back open. He states there were rocks in the bottom that were preventing the doors from working properly.

FINANCE

Amy Webber reports that with two more months to go, we should be close to the budget for income.

ALTAR AND ROSARY

Shirley reports hearing that everyone was pleased with the parish breakfast last Sunday.

OLD BUSINESS

Mike Adrian presents two estimates from Greiner Masonry to Replace the severely damaged brick for \$2,600.00 and then another estimate to grind out all mortar and damaged brick for \$6,400.00. Mike has requested that Bret Greiner provide an estimate to match that of what Leonard Drish previously presented to the parish council. He has not received this and reports feeling as though Bret was 'not excited' to provide this number to Mike. The estimates do not include the brick on the inside of the bell tower as Mike reports Bret indicated the most severe bricks are on the outside. Mike does indicate that the estimate includes bricks. Jeff Ledger does indicate that the church owns brick that has been paid for but is sitting at another masonry business. Jeff is planning to double check on this and will report back to the parish

council. Mike will ask for a new estimate that does not include the cost of paying for brick. He will also ask for an additional estimate to include the same services as the previous bid that Leonard presented.

NEW BUSINESS

Mike Adrian presents an estimate to resurface the parking lot at St. Joseph. The estimate has two options listed as Type A Work and Type B Work. The total estimate including both types of work, cold mix patching, and stone base material is \$15,484.20. In comparison to the work completed in 2010 and 2014, the square yards listed on the estimate do not match. Mike plans to contact LL Pelling again in regards to this. Mike also has not heard back from the county engineer to see if the county will pay for their portion.

Mike Adrian reports that trees were donated by Rosemary Pacha. He reports the trees are Burr Oak trees and is planning to plant them Friday evening near where the ash trees were that were removed.

Shirley reports we need to be thinking of ideas of things that we can do for evangelization in order to present this at the Vision 20/20 convocation June 6-8.

The parish bazaar is scheduled the August 25, 2019. Shirley requests people start thinking of raffle items.

Shirley reports the graduation mass is scheduled for May 19th.

A closing prayer is read by all.

Dennis Linnenkamp moves to adjourn the meeting. Kelsey Rubey seconded. The next meeting is Wednesday, June 12, 2019 at 7:00 P.M. at St. Joseph. Meeting adjourned at 8:24 P.M.
