Notes to the Financial Statements

Saint Mary's Parish:

- Sami Mary 8 Paris
- Total parish collections for FY23 were up 4.60% from the prior year. Our collections remain lower than they were pre COVID. **We ask that you consider increasing your weekly collections.** This will help maintain a financially strong parish and support our parish ministries. We continue to encourage everyone to participate in our *Electronic Giving program* as an easy way to automate your regular offering and provide much needed donation consistency to allow us to meet our weekly operating needs.
- In FY23 our average weekly collections were \$14,811 (\$14,159. in FY22). The average weekly operating cost was \$14967. (\$15,387. in FY22). Without an increase in collections, we will have to begin to use our savings to cover our operating costs. This will have an impact on our ability to offer other programs and enhance future parish initiatives.
- Other income is generated from rental income from the cell tower located in the bell tower, donations from the candles in the Mary Chapel, advertising income from the bulletin and other gifts and bequests made to the parish. In June of 2023 T-Mobile/Sprint decided NOT to renew the rental agreement. This is a loss of \$36,000.00 in income annually.
- Operating expenses for the Parish decreased 2.73% in FY23. Liturgical and pastoral expenses and operating supplies and services rose significantly. We continue to monitor all operating expenses and work with our vendors for the best pricing packages to ensure we spend prudently and within our means.
- Building and Maintenance expenses include landscaping, snow plowing, property liability insurance, electrical and heating repairs as well as other minor general maintenance items.
- Operating expenses also include diocesan assessments paid to the Diocese of Springfield for diocesan wide programs and support (i.e. legal, building and construction oversight, management of benefits etc.). This 6% assessment is based on recurring revenue generated by the parish.
- The Extraordinary Activity section is incorporated to segregate non-recurring, and or non-operating revenue and costs from the ordinary operational account. This manner of presentation allows us to report the information in a comparative format.

Notes to the Financial Statements (continued)

Extraordinary Activity for the Parish includes the following non-operating items:

• The parish is continuously challenged to implement programs and ministries to expand our focus on energizing the role of youth in our community, promoting and supporting excellence in Catholic education through St. Mary's Academy and Faith Formation Programs, as well as addressing the needs of seniors. We also have a comprehensive preventive maintenance program in place to ensure we avoid costly expenditures in the future.

Saint Mary's Academy:

- St. Mary's provides quality elementary education to students in grades Pre-Kindergarten through Grade 8 and is accredited by the New England Association of Schools and Colleges (NEASC).
- The Academy has 3 major revenue sources, tuition, the extended day program and fundraising. The extended day program and fundraising play a critical role in supporting the operating expenses while keeping the tuition at a level that is competitive with other Catholic schools in the area.
- Cost for the Academy teachers and staff is 84% of operating expense. We are continuously challenged to provide a competitive salary and benefits package to our teachers and staff to maintain the high-quality educational standards at the Academy.
- St. Mary's Academy procured additional funding through EANS (Emergency Assistance for Nonpublic Schools) federal program. This funding is used for technology improvements and mandated regulations in classrooms.
- We continue to monitor all operating expenses and work with our vendors for the best pricing packages to ensure we spend prudently and look to combine the purchasing power of the Academy with the Parish to get vendor discounts and better pricing proposals.
- Extraordinary Activity for the Academy is dependent on the level of fundraising that can be generated beyond what is needed to support operational expenses. This combined with grants allows for enhancements to curriculum, technology, and other program initiatives that will allow the Academy to differentiate our educational experience from other schools that we compete with.
