Church Environment Report: Nancy has posted the Lent bulletin board, which will remain until Holy Week. Katie Borgen cleaned out the storage room and created space for Joe's use. The statue of St. Gabriel was located and has been displayed. Katie B. has made arrangements for getting the Easter decorations displayed while she is out. The colors will be changed for Ash Wednesday, and Mike will be setting up the ashes. Nikki suggested adding some artwork to the hallway that connects the Church to the Parish Hall; Nikki will follow-up with Celia. Mike added that the original crucifix from St. Hubert's could be displayed as well.

Ash Wednesday (Feb. 22, 8:30 AM and 7:00 PM): Ushers are needed for Wednesday morning; Roy will follow-up.
