I will be responsible for the replacement, at full retail value, of any equipment rented under this form which is not returned to the shop, and I acknowledge my obligation to return this equipment by the agreed date in clean condition, to avoid any additional charges. I agree to hold harmless and indemnify the organization that rented or allowed me to use this equipment, as well as it's owners, agents, employees, for any loss or damage, including any that results from claims of personal injury or property damaged related in any way to use of this equipment - except reasonable wear and tear of equipment itself.

I understand that the board/boot/binding system **WILL NOT ORDINARILY RELEASE DURING USE, NOR IS IT SPECIFICALLY DESIGNED TO RELEASE** as the result of force induced during ordinary operation, and is therefore no guarantee of my safety.

In consideration of all of the above and also in consideration of the equipment being rented to me or at my request, I hereby **release** owners, agents, and employees, and the manufacturers and distributors of this equipment, from any and all liability for damage and injury to myself or any person or property resulting from negligence, installation, maintenance, the selection, adjustment, and use of this equipment, accepting myself full and complete responsibility for any and all such damage or injury or death which may result (excluding willful, wanton or intentional acts). I have made no representations to the renting or providing organization with regard to any information which they have requested of me related to the rental and/or my use of the equipment. Instructions on the use of this equipment has been made clear to me, and I understand the use and function of my equipment.
