Payment Options:

ALL FAMILIES MUST UTILIZE FACTS FOR ALL PAYMENTS THE 2024-2025 SCHOOL YEAR

FACTS is a tuition payment and processing system. FACTS accepts payments ACH through checking or saving accounts or credit card. Once registered with St. Patrick School, you will receive further directions via email.

- Annual (2% discount) – Payable only through FACTS.

- Paid by Friday, July 19, 2024.

NOTE: There is a yearly FACTS fee of \$25.00.

- 10-month payment plan, (August through May) – Payments will be made through FACTS.

NOTE: There is an annual set-up fee of \$55.00 for FACTS.

NOTE:

- ♣ **5% Discount** on tuition for children in Early Childhood Program if families have multiple children in Preschool /Pre-Kindergarten and/or Kindergarten - 8th Grade.
- ♣ **EARLY CHILDHOOD \$250 REBATE PER YEAR** – Parents whose children attend our early childhood program and continue on in Kindergarten at St. Patrick School will receive \$250 toward their kindergarten tuition. For example, if your child attends preschool and pre-kindergarten at St. Patrick School and continues on in kindergarten, you will get \$500 off your kindergarten tuition at St. Patrick School.
- ♣ **NEW FAMILY REFERRAL \$250** – Refer a family to St. Patrick School and receive \$250 off your tuition. The new family must register and attend the 24-25 school year.
