Release Time classes for religious instruction will be conducted in churches listed below so your child may receive the benefits of instruction in the faith of your choice. These classes are for the sole purpose of giving religious instruction. In order for this to be a positive and effective program, it is crucial that there be full cooperation of the students and parents/guardians. It is expected that each student and parent/guardian read carefully the material below. Before your child may participate in Release Time classes, this completed form must be turned in to WHA and then it will be given to the church.

The student will be admitted only to religious classes in the church specified herein. Students enrolled in the classes of one church may not during the year transfer to the classes of another without written consent of the parents/guardian & verbal consent of the involved churches. Attendance is taken. It is understood that the below parents/guardian & students' signatures are promises of their cooperation with churches. If a student becomes uncooperative & does not respond appropriately in class or to a teacher, the church will notify the parents/guardian & WHA. Future participation may be affected with the possibility of not being allowed to return.

I consent to the participation of my child/ward in the below named activities. In consideration for my child/ward's participation, I agree to this indemnity agreement to reimburse and indemnify the below named parish as checked on backside for all reasonable legal and court fees incurred by parish in defending a lawsuit that I or my child/ward may bring against the parish/school which relates to the below named activity if the parish is found not legally liable by the courts and prevails in the lawsuit. If the parish/school is found liable for the injuries sustained by child/ward, this paragraph will not apply.

I authorize transportation to the activities provided by the church marked below for grades K-5th grade. I certify that I have an understanding of this agreement and the risks and hazards associated with the activity described below that my child/ward will be participating in. I further understand that I had the opportunity to fully discuss this agreement with a representative of the parish to clarify any concerns or questions about the activity or this agreement that I may have had.

The parent/guardian agrees to hold harmless the church if an injury occurs during Release Time. In case of a medical or behavioral emergency, the church will attempt to call both the parents/guardian and WHA. The parents/guardian hereby give permission to the church to transport the student, if deemed necessary, to WHA, a local clinic, or to call 911.
