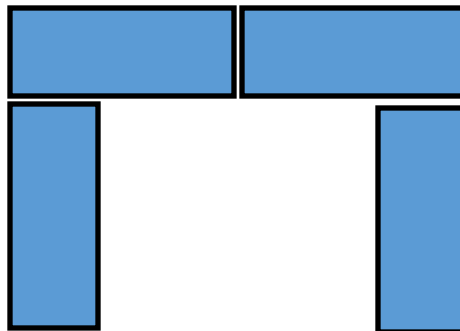
- Indoor Market of Local Crafters and Vendors

## **Market information and Requirements:**

- One 8' table is supplied to each vendor unless a request is made to leave the space empty. A plastic table cloth and skirt will be on each table. Booth spaces will be clearly marked. Spaces are approximately 8'6" by 6'.
- Crafters/Vendors with tall items need to be placed against a wall, please include this information in your description of items.
- Booths with electrical access are very limited and given on a first-come, first-serve basis. Extension cords are not provided.
- All vendor location requests will be considered on a first-come, first-serve basis and will be honored whenever possible.
- Minnesota ST-19 Form is required and will be provided in vendor packet.
- Free Parking is available for all exhibitors in our alley lot. After unloading, please park along the far West side of the lot.
- Set-up time will be provided on Friday from 4pm-7pm. Hall will be open to exhibitors on Saturday morning at 8:00 am.
- Exhibitors must tear-down and be cleared from the property by 3:00 pm after the event due to the arrival of parishioners for the evening Mass.
- To prevent accident or injury, exhibitors wishing to leave early may request permission to do so from the event coordinators and items may be walked-out. Vehicles will not be allowed on the walkway during the event.
- This event occurs rain or shine!
- **All vendor fees are non-refundable.** *Verbal reservations held for 30 days.*
- Please fill out vendor registration completely.
- Vendor registration form must be returned by August 1st.
- Each applicant will receive a confirmation letter upon receipt of their application.
- Informational meeting and preview for exhibitors will be held at St. Mary, Star of the Sea's McDowell Hall at 6:00 pm on Friday, October 11th. Exhibitors will receive a vendor packet with additional information as well as have an opportunity to see the space provided to exhibitors.
