Hebron Housing Services

· Siena House Shelter will return to his regular hours on Monday, June 1st. The house will go back to being closed Monday through Saturday from 7am-6pm. Hours of operation are 6pm-7am and open 24 hours on Sundays.

Community Action Coalition (CAC)

- · CAC has been awarded as part of the Governor's WRAP Program being administered to CAP agencies throughout Wisconsin. Information on this program is forthcoming and we expect to launch it on June 8th. It is an eviction prevention program for people under 80% CMI in Dane, Jefferson and Waukesha Counties. Right now, CAC does not have a lot of details, but CAC will disperse in the information as soon as they have it.
- · CAC is also working on a program for all 3 of our counties using CSBG (Community Services Block Grant)-COVID money. More information to follow.
- · CAC is still pulling people from the lists for Rapid Re-housing. CAC has been housing people, albeit slowly, but they are trying to work through everything with people during this time!
- · There is nothing to report on PSH. There are no openings at this time.
- · CAC is discussing the possibility of applying for a Rapid Re-housing for DV victims' program through the CoC grant.
