## **COMMITTEE REPORTS:**

### Sean Kunath: Liturgy/Worship

- Source and Summit missal is recommendation, costs about the same as the Breaking Bread Missal-approx. 6.86 per missal 823.20; Source and Summit 6.21/missal
  - Needed ideal congregational hymns, not found in other missals that had Spanish/English options
- Sanctuary renovation project compiled profile of recommendations
  - o Gothic style vs. Romanesque design

  - Need volunteers, 9-10,11-12 needed especially

- Working on prolife crosses
- Cross the Bridge for Life June 4, need volunteers

## Pete Manczyk - Deanery Representative

- Process changing with new Bishop wants to know how best to serve the parish
  - Will continue with Deanery
  - The Diocesan Council 2 reps from each Deanery; this is who will formally communicate with the Bishop (all laity)
  - Deaneries will meet 5 x a year, Diocesan Council will also meet 5 x/year; meet in smaller groups, more free-form communication

# **NEW BUSINESS:**

# **Update on Landslide** – Diocese helping, potential lawsuit with Water District

Pursued the issue, Cardinal Engineering did joint test the Water District that gives conclusive evidence that the pipe in the hillside is pressurized/has water in it – was marked closed but still active, ran test over 1 month and no reduction of water coming out

Report/recommendation is that Water District needs to address the issue of the pipe in order to fix the hillside

Unsure how receptive Water District will be, but have received letter from lawyers to talk/visit site and come to a resolution

Letter sent to Bishop regarding permission to commence church renovation – no response at this time

Open house to see upgrading of rectory
