

# St. John the Evangelist School Tuition We Share Tuition Authorization ACH Debit/Credit Card Payment Form

I (we) authorize St. John the Evangelist Catholic Church and School through WE SHARE (its online payment service) to initiate Automated Clearing House (ACH) or credit card debits from my (our) financial institution account, as defined below, to the parish school account.

This authorization is to remain in effect until the school family either changes the amount of the school tuition payment or revokes its authorization by providing 30 days written notice of revocation to the school.

It is understood that the school family will be considered in default for any reason the ACH/Credit Card transaction cannot be completed. The school reserves the right to remove the school family from the ACH/Credit Card system due to rejected transactions. A \$25 fee will be assessed on all non-sufficient funds (NSF) or rejected transactions.

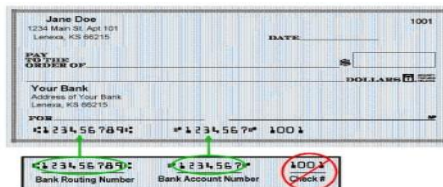
