St. Ignatius is foremost a Catholic school where two, three and four year olds are given the opportunities to develop spiritually, socially, physically and intellectually. We seek to provide faith filled, qualified teachers to work with our children. We also strive to keep tuition rates affordable for those families seeking a Catholic environment for their children.

In providing a quality program it is necessary for St. Ignatius Early Childhood Center to utilize its teachers and classrooms at full capacity, as often as possible. Our VPK program is 5 days a week and we offer 2 and 3 day options for the two & three year old programs.

Tuition rates for the 2022-2023 school year will increase for the first time in three years as follows: Annual 5-day Tuition \$4000.00, 3-day Tuition \$3600.00 and 2-day \$2800.00. We also offer before and after care with Morning Crew Monday – Friday from 8am until 9am for \$6.00 per day per child, and Lunch Bunch Monday – Friday from 12 - 2pm for \$12.00 per day per child.

Applicants will receive a welcome letter via mail in mid-July. This notification will contain all the information regarding required documents that you will need to have in order for your child to begin school at St. Ignatius Early Childhood Center.
