Q & A for ACH Automatic Withdrawals for Parish Contributions

What is ACH?

Automated Clearing House (“ACH”) is an easy, efficient way to make your weekly or monthly contributions to your parish. Your pledged contribution is automatically withdrawn from either your Savings or Checking account by your bank and transferred to the parish bank account.

Why should I do ACH?

ACH is a convenient way to make contributions to the parish. If you are out of town, on vacation or busy with the kids or grandkids, your support of the parish is assured.

How do I sign up?

Initiating ACH is as easy as completing the form below and submitting it along with a cancelled check or savings deposit slip to the parish office. You determine the frequency and the amount of the withdrawal. Shortly after you sign up, your contributions will be conveniently withdrawn from your account and you will no longer receive or need to submit weekly offering envelopes.

Can I change the amount I contribute during the year? What if our income changes? Are we obligated to continue at the amount we chose for the entire year?

You are able to change the amount, frequency or even discontinue the transfer at any time – just submit your request in writing or contact the parish office for assistance.

Will I “get credit” for the contribution and is it tax-deductible?

Your tax-deductible contributions will be recorded in the parish records as a regular Sunday offering. Each January, you will receive an annual statement which details your contributions for tax purposes.

How do I know this is safe? I am afraid you will have access to my account.

Your banking information is secured in a locked cabinet in the parish office. Once we provide your information to our bank, our bank conducts all electronic communications with your bank – the parish NEVER has access to your bank account.

My bank isn't local. Can I still participate?

Yes, you can have the funds withdrawn from any U.S. based financial institution. A local branch is not required.
