3. Current Financial Report and Collections Report

- **Current Financial Statements December 31, 2020** Net incomes up \$210K from last year, mostly due to investment income as well as a reduction in the cost of major projects.
 - Revenue is up \$161K from last year, mostly due to investment income.

• Weekly Collections Report

• Down \$52K from this time last year. Collections are down, but parishioners are partially making up for the lack of visitor contributions, which were down \$67K.

• Status of PPP Grant

- A new PPP form is coming from the government to obtain forgiveness of loan and turn it into a grant. This must be filed the first week of February.
- Stella Maris Parish has met all the conditions to turn the loan into a grant.
- Fish Creek assessment for road improvements for Stella Maris is \$28k
 - Deacon Tony will verify that the parish does not have to pay this, the general taxpayers in the town will share the cost.

4. Pastor/Minister of Finance, Facilities, and Administration Report

- Second PPP Loan/Grant
 - o SMP is financially secure at the present time. The parish will not qualify for the second grant.
- Line of Credit Nicolet Bank approved up to \$50k. Taken out only if needed.
- Budget Process Update
 - The Pastoral Council will identify their short-term goals and report this at the joint The Pastoral Council will identify their short-term goals and report this at the joint Pastoral/Finance Council meeting in February/March.
 - The budget will be completed in May.
 - The Stewardship Committee needs the completed budget by June.
- Parish Mission Planning

- This is a 3 year plan which will begin in 2022
- Volunteers are needed for a leadership committee which will have the appropriate skill sets.
- Bulletin inserts regarding the leadership committee will begin in March

5. Committee Reports & Project Updates

- Stewardship Committee
 - o Volunteers needed for additional fund raising.
 - The food pantry has been well-stocked with donations. Suggested that the overflow of food be shared with the food pantry coalition in Northern Door.

Endowment Committee

- The endowment had a FMV of \$953K as of 12=31=2020.
- The distributions of 4% per year will begin when the \$2,000,000 mark is reached.
- Bulletin inserts will begin reporting endowment statistics.
- Buildings and Grounds
 - Next meeting in February. No immediate concerns or safety issue.

6. Discussion Items

- Joint Meeting with Pastoral Council late February or early March
- Update on One-by-One Archdiocese Campaign
 - 63 parishes are still obligated.
 - Stella Maris is in the 3rd wave. Diocese is requiring \$662K for 1 X 1 capital campaign. Of this amount, \$331K will be returned to the parish and used for Mission Planning.
 - Volunteers wanted to help with the fundraising.
- Finance Trustee election will be the weekend of February 6/7
