• Stewardship Committee

- Tom reports that the Stewardship committee will kick off Stella Maris' annual campaign the week of June 24/25, 2017.
 - > As per last year's campaign, the committee will send out information via first class mail.
 - Last call for Service and Sharing forms will be week of July 8/9
 - Follow up calls planned for the last two weeks of July.
 - Discussion of how to measure success of Stewardship: financial support is certainly a consideration; volunteers per household is being counted; how many participants in growing the faith and discipleship within the faith community of Stella Maris.
 - Annual Report: request for non-financial input to be sent out before the end of June
- o Bernie Freeman: Endowment Update
 - Endowment planning committee consists of Becky Nash, Bernie Freeman, Tom Polacek and Mark Kunstman and Jim Frings..
 - To be successful, the endowment needs the following to happen:
 - 1. Parish leadership informed and committed to the endowment
 - 2. Given enough time, the endowment should have a corpus of \$4 \$5 million. For this to happen we will need to secure several large lead off commitments.
 - 3. We need to develop a solid plan. An endowment advisory team which we plan to form this summer will play a key role in this step.
 - 4. Various handouts need to be produced to update our parishioners

Visits and/or inquiries of other parishes that have endowments to find out how they accomplished the funding of the endowments and talking with a representative of the Diocese is also on the to-do list.

Buildings and Grounds

- New Furnace SB
 - Approved to purchase new furnace after pricing various units. Joan Schaupp has offered to pay for the purchase.
- New Refrigerator FC
 - Approved. New refrigerator will be 15 Cu ft. residential type refrigerator. No need for large commercial type.
 - Need to purchase residential-type refrigerator for Baileys Harbor so that the commercial refrigerator there would only be used at the time of large events.
- Old Lawnmowers
 - > Approved the sale of the 3 old lawnmowers. We will initially run a notice in the bulletin.
