2. Current Financial Report and Collections Report

- Financial statements of March 31, 2023 were reviewed
 - Income \$18K above prior year, expenses \$185K above prior year, driven by major projects including the painting of the Egg Harbor sanctuary and the rebuilding of the Baileys Harbor northern wall.
 - YTD investment gain of approximately \$45K
 - Endowment fund at \$1.09 million
 - one by One campaign receipts of approx. \$180K, shown as an asset and a liability until disbursed to the parish. Anticipate withdrawing funds quarterly with 1/3 being used to fund major capital projects and 2/3 going to the Endowment Fund.
- · Weekly Collections Report was reviewed
 - o YTD collections were \$51K above the prior year and are running \$23K above Budget

3. Pastor/Minister of Finance, Facilities, and Administration Report

- one by One Update
 - We anticipate receiving \$1,975,000 over five years and will budget capital projects accordingly.
- · Buildings and Grounds update
 - Baileys Harbor retaining wall rebuilt at a cost of \$90K, favorable weather allowed for completion this spring.
- Stewardship drive being planned beginning with Ministry Opportunities (Building our Faith, Worshipping Together, Reaching Out to Others and Supporting Our Parish Operations)
- Discussed implementing Fellowship After Mass (Family) with each ministry offering to host the weekly events.
- Beginning the process of preparing the annual financial report to the Diocese

2. Review of FY23/24 Budget

- Preliminary Budget Reviewed
 - A Budget of \$780K was established for Parish Support as we are seeing a return of church attendance to pre-pandemic levels.
 - Approved the salary adjustments for the year, establishing a minimum wage of \$17.00 per hour in order to remain competitive in the Door County labor market.
 - one by One campaign receipts of \$99K Budgeted (excluding Endowment), with major capital expenditures equal to the one by One receipts (\$99K)
