I. Pastor's Outlook:

- **Finance** It was brought to the attention of the council that collections have seen a noticeable drop. In light of this, we need to study why this is occurring. Both the Finance Council and Stewardship Commission will assist in helping to identify ways to correct this negative situation.
- Properties The Diocese has been contacted regarding the selling of the house and land next the Sister Bay church and regarding dividing the 17 acres on County A & County F Roads. Necessary repairs are being made to the house prior to putting the property on the market.

## J. Information Items:

- Youth Alive Steak & Shrimp Dinner Report The sixth annual event co-chaired by Marvin Leppert and Ed Schmidt with the help 38 volunteers was enjoyed by over 170 participants produced a net profit of \$3036.00 for parish youth projects.
- Parish Vitality Indicators Survey Results At the June 2014 Pastoral Council meeting members took the
  survey. Results indicate that liturgy and pastoral leadership are strengths on which to build the areas of
  concern which include: Parishioner Involvement, Evangelization, Life Long Formation, Welcoming and
  Responding to the Needs of People. Sharon Brabson suggested that Commissions and Committees take
  the Survey to get a broader view of how parishioners view our parish vitality. (Report attached)
- **Definition of Role and Responsibilities of a Liaison** As we move from an At Large Council to a Representative Council, some members will be council members by virtue of their participation in the commission bringing the needs and interest of the committee to the council and then returning to the commission with the actions of the council. It is designed to improve a working relationship and communication between the Pastoral Council and the Commissions.
- **Duties of Vice-Chair and Secretary of the Pastoral Council** The role of the vice-chair is to fill in during the vacancy of the chair and to act as parliamentarian keeping the discussion time to no more than three minutes per member. The role of the secretary is to take the minutes of the meeting and as soon as possible after the meeting to get the minutes ready for distribution.

# K. Communication Items:

- Stewardship Commission Update Tom Polacek and Becky Nash, Pastoral Associate attended a Stewardship Day program at the Diocese and learned a number of ideas. There was a call for women to participate since currently Becky Nash is the only woman on the Commission and she is parish staff. There will be no Stewardship Fair this year. This is generally a successful way to recruit parishioners to participate in the ministries and committees of the parish. A report of past action and planned activities was shared and reviewed with the Council members.
