- 1. The Meeting was called to order at 7pm utilizing Zoom Conference media.
- 2. The May minutes were approved.
- 3. Plans for Future Gatherings:
 - a. A Parish Letter will be sent out to parishioners from St. Joe giving directives for Mass attendance.
 - i. Disinfecting will be done between Masses supervised by St Joe Facility Supervisor and the Knights of Columbus volunteers.
 - ii. Don Trudeau Knights of Columbus will assist supervising volunteers.
 - iii. Waivers will be posted and signed by assisting personnel, sign a logbook, and will utilize the use of masks and safety mechanisms.
 - iv. Weekend Sunday Mass times: 8:30 am & 10:30 am.
 - v. Congregation attendees will be required to register for Mass online prior to the weekend attendance, limiting attendance to 62 households per Mass. (approximately 225 individuals maximum. Attendees will be ushered to and from Mass by hospitality ministers. Attendees are to wear masks while attending Mass. Communion will be distributed at the end of Mass as attendees exit the church. Directions to receive Communion will be announced by Fr. Mike at the beginning of Mass.
 - vi. Individuals not attending mass but desiring Communion, drive up Communion will be available following the Sunday 10:30 am mass.
 - vii. Mass will continue to be recorded and available online.
 - viii. There will be no singing at Mass. Cantor music will be prerecorded and inserted into the recorded Mass available online.
 - ix. The attendance at Mass plan follows the CDC and Archdiocese of St. Paul directives for COVID-19 safety. It remains a flexible plan as needs arise.
- 4. Synod Disciple Maker Index (DMI) results
 - a. The DMI Survey results are available for churches to review.
 - b. There is a 3-step process to obtain the survey results available June through October 2020. Webinars showing how to view the results. PPC Members are invited to watch the Webinars.
 - i. The DMI survey results will be helpful to continue the visioning process this fall.

7. Financial Update

- a. Fiscal Year Updates:
 - i. As of April 2020, collections were down approximately \$69,000.
 - ii. Expenses are lower than original budget for fiscal year 2020
 - iii. Fiscal year 2020 it is anticipated that St. Joe's will break even.
- b. Payroll Loan Program
 - i. St. Joseph's received a Payroll Protection (PPP) Loan.
 - ii. Purpose is to cover employee payroll through end of June.
 - iii. A bill was introduced in legislation to increase the payroll coverage to 24 weeks from 8 weeks.
