- 1. The Meeting was called to order at 7pm utilizing Zoom Conference media.
- 2. The March minutes were approved.
- 3. Plans for Future Gatherings:
  - a. Next meeting for Parish Pastoral Council is scheduled for June 2.
  - b. Archbishop Hebda COVID Directives
    - i. Phase 2 is planned for May 18 to include Church Gathering/ Mass with safety restrictions, process allows for a slow rebuild and reopening.
    - ii. Sunday Obligation Dispensation remains in effect.
    - iii. Church may utilize 1/3 seating with social distancing, masks, and sanitation procedures.
    - iv. Mass will continue to be recorded and posted on Sunday
    - v. Ordination of Deacons and Priests will take place with limited audience.
    - vi. Recommended persons 65 and over/ vulnerable adults/ illness remain home from Mass gatherings.
    - vii. Fr. Mike will continue to have staff discussions regarding best practice for our congregation and implement appropriate measurers as needed.
    - viii. Communication with congregation about mass times and communion distribution will occur utilizing web site and emailing to parishioners.
    - ix. Fr Ken and Deacon Tom have indicated they will continue to say mass.
    - x. Current funerals and weddings are limited to 10 people/ small groups.

### 4. Financial Update:

- i. Weekly update: Behind Budget March 21%, Easter 23%, April 8%
- ii. Expenses in April will be down-lowering the amount of budget deficit.
- iii. PPE Loan has been applied for and approved.
  - 1. Account was opened and paperwork signed.
  - 2. Payroll protection \$155,000.
  - 3. Churches that comply with requirements can be given loan forgiveness.

#### iv. Archdiocese:

- 1. Have offered a significant reduction in Insurance and the Annual Assessment. Payment can be delayed if needed.
- 2. Approximately \$15,000-\$16,000 relief.
