Tuition Deposit Due Date: A non-refundable tuition deposit in the amount of \$50 per student will be due on or before March 1, 2023 for the current enrolled 2022-2023 students. Registration after March 1, 2023, there will be an additional \$20 per family late registration fee. \$20.00 late registration fee per family will not be reimbursed and/or used towards tuition fees (late registration fee applies to current enrolled 2022-2023 families only).

As school parent(s)/guardian(s), we/I understand that if my/our financial obligations to St. Peter Catholic School are not current, registration for the following year will not be accepted until the matter has been resolved. All payments should be made or mailed to St. Peter Catholic School. Parent(s)/guardian(s) of school children who are Tri-Parish parishioners are required to support the school and parish. In addition to the tuition, parish dues should also be paid and current.
