EFFECTIVE JUNE 1, 2017**

Effective June 1, 2017, 40% of the SCRIP REBATES goes towards St. Peter Catholic School and 60% of the SCRIP REBATES goes towards one of the choices listed below.

St. Peter Catholic School (referred to herein as "we", "us", and "our") sponsors a SCRIP program which allows you to purchase SCRIP.
