Please note these important due dates regarding the submission of applications for St. Peter Catholic School Education Scholarship Fund:

May 1, 2019 for the 2019-2020 Academic Year

August 1, 2019 for late registrants for 2018-2019 Academic Year

October 1, 2019 for those whose life changes require scholarship application

January 3, 2020 for those whose life changes require scholarship application

(Significant loss of income, death, divorce, etc.)

Our purpose is to ensure a fair and equitable distribution of scholarship funds to families via a process that maintains the privacy of applicants and awards the scholarship funds based on basic standards of need, asset and income levels and parish community involvement.

GUIDELINES FOR COMPLETING ST. PETER CATHOLIC SCHOOL EDUCATION SCHOLARSHIP FUND APPLICATION

The following guidelines will help you as you fill out the scholarship fund application. The application along with any required information must be returned prior to May 1, 2019; August 1, 2019; October 1, 2019; or January 3, 2020 to:

1. Scholarship Funds are available for full-time K3 through 5th grade tuition only based on parish membership, school registration, participation and financial status.
2. All questions must be answered or the scholarship fund application will be returned to you. This may result in a delay in determination of scholarship fund award.
3. The information on the scholarship fund application may be verified by the Principal at any time during the academic year. Additional information may be required as needed.
4. Decisions made by the St. Peter Catholic School Education Scholarship Fund Committee are final.
5. Any and all information that you provide will be treated confidentially. All information will be kept for one year. No files will be maintained of your information after one year. After one year, all information will be destroyed.

7. You will be notified of the final status of your scholarship fund application approximately thirty days after the appropriate submission deadline.
8. Income, as indicated on the scholarship fund application, includes **any and all sources of money earned by your family.** These sources include, but are not limited to:

*Dividends and interest of any kind
*Unemployment compensation
*Alimony/Child Support

*Self employment income/Royalties
*Unreported cash income
*Welfare/Assistance
*Retirement or Pension
*Financial contributions from others
