

FORT SMITH CATHOLIC SCHOOLS Strategic Growth Plan: Challenges

The Fort Smith Catholic Schools' Executive Committee, Steering Committee and Planning Area Teams have spent the past seven months working on a Strategic Growth Plan that will provide direction and vision for the future of Catholic school education in this community. During this time, the following has been accomplished:

- * Organization of the Plan around the four domains of: Mission and Catholic Identity, Governance and Leadership;
 - Academic Excellence and Operational Vitality;
 - * Creation of Purpose Statements for all Planning Areas of the Four Domains;
 - * Creation of Challenges for each of the Planning Areas;
 - * Creation of preliminary Strategic Solutions to the Challenges;

In June, the leaders of the Strategic Growth Plan will reach out and invite members of the overall Fort Smith community and beyond to come for an evening Convocation on June 3, 2019 and offer an objective view on how to solve the challenges. After input from all of the planning groups, the Strategic Growth Plan Document will be presented to the Executive Committee (pastors and principals of Fort Smith Catholic Schools) in July 2019 for input and revision before being presented to the superintendent of Catholic schools, Theresa Hall. After review by the superintendent, the Plan will then be presented to Bishop Anthony Taylor for final input and priority. Implementation of the priorities of the Plan are scheduled to begin in the fall 2019.

Below are the Mission/Vision Collaboration Statement and the 21 Challenges that will be introduced on June 3rd at the Convocation.
