Feb 1<sup>st</sup> Leadership Day. That is the day that is on the calendar to finish up PMP Goals and meet with all councils. Ann is not able to make that day and Jared was in question. Father had heard from others that there were conflicts on that day and may have to reschedule. Does it have to be a full day, or could it happen after mass on a Sunday for a pass a dish lunch and wrap it up in a couple hours? He will get back with the decision that is made and how to proceed.

Bishops Appeal and shortage and how to address this with the parish. 2019 we were \$2650 short. It was suggested that it may not be known by the parishioners that if we fall short of the appeal goal that the balance comes out of the parish no matter what is raised. Maybe if they knew this they would help meet the goal. Also thought we could put some challenges, like whoever donated by a certain date gets this (?) in return. Further discussion is needed.
