FEES

The Annual Registration Fee for each currently enrolled student will be \$100. Registration Fees for new students are due at the time of registration. Registration Fees for existing families within the school are due June 1, 2018. Families who select automatic bank draft for tuition payment will have the Registration Fee withdrawn in June. Licenses, Books and Exam Materials Fees for each student (K-6) will be \$150. Licenses, Books and Exam Materials Fees are due on August 31, 2018. Families who select automatic bank draft for tuition payment will have the Licenses, Books and Exam Materials Fees withdrawn in September. Snack Fees for each Pre-K student will be \$50. Pre-K Snack Fee is due on August 31, 2018. Families who select automatic bank draft for tuition payment will have the Pre-K Snack Fee withdrawn in September.

VOLUNTEER HOURS

All families are required to work fifteen (15) volunteer hours for their first child and five more hours for each additional child for a maximum of twenty-five (25) hours. Five (5) of your volunteer hours are mandatory hours at the Lawn Social. **All hours not documented will be billed at a rate of \$10 per hour on your end of the school year statement, with the exclusion of the five(5) mandatory Lawn Social hours which may be billed at a higher per hour rate.**
