Dear Market to Market & Craft Fair Friends,

We are happy to let you know that the Market to Market & Craft Fair will be held November 8-9, 2025. We hope that you will be able to participate again and for those who have had previous engagements in the past, we hope that this will be a good date for you. Being open on Sat. and Sun. rather than Fri. and Sat. as many of you suggested worked well last year so we are keeping the Sat./Sun. schedule. In addition, you suggested having tent spaces outside, off Courtenay Pkwy., as this would attract more patrons, so we are offering that too as well as the outside along the sidewalk by the parking lot. We will have additional signage stating that there are vendors both inside and outside. Half of our inside spots are already filled for this 2025 year. When inside spaces run out there is always outside. It is best if you have a tent for the outside.

Just a few reminders below:

1. I will need to know if you are bringing a small (6') table to go with the 8' table that we provide. **(For the inside spots)** Six-foot spaces are limited to the end of rows, this is where they best fit. **Sorry but we are not offering a table for the outside spaces. The fee is still the same at \$55:00 for two days.**
2. You are responsible for your tablecloth and set-up.
3. Absolutely no tents are allowed inside.
4. Let me know if you have a prop that will need to go behind your table, as I will have to place you along the wall and that space is limited.
5. Please advertise to those that follow you, via whatever media you use. We do want to get the word out as much as we can. Feel free to share our flier when you advertise. We advertise via many social media, radio, several marques, and town papers.
6. **Set-up is required on Nov. 7th at 2:00 p.m. I will be there until 6:00 pm. Or until all are set up. (I can meet earlier too for those that want to set up earlier on the 7th.)**
7. If vendors with tents want to set up on Sat., please be there no later than 7:00 am to set up.
8. We do have lunches available for \$7.50 this year.
9. **On Sat. and Sun., please park further out in the parking lot so that our parishioners and patrons have convenient parking. Be mindful that our Sunday parishioners take up all the disabled parking.**
