Personal Safety Training

The Office of Child and Youth Protection in Washington, DC requires the safe environment training for children in religion education programs. This year we will use the VIRTUS Empowering God's Children program to teach personal safety concepts in an age-appropriate manner in accordance with Catholic tradition and theology. This is a REQUIRED training each year for the children. Each class (K-11) will have a scheduled time during PSR to complete this personal safety training program. Sessions for each grade level will be on a four-year rotation cycle. Grade 12 will complete the Safe Haven Program from Catholic Mutual Group closer to the end of the school year. Parents are always welcome to view these trainings with their child or opt-out completely. Please carefully consider the best option for your family and answer the questions below.
