**Update** – Bob found some additional burials in Sts. Peter and Paul Cemetery while he was researching the Find-a-Grave site. He has been emailing with a woman named Sharon who has done extensive genealogy work on her family in this cemetery. Sharon gave him copies of the Sts. Peter and Paul Death Record Book from the 1800's. These records show entries (signed by a Fr. Nicholas Becker) of burials in our cemetery that are not in the records we have. This new information includes twin brothers, Joseph and William Gentz. One died before he was 1 year's old. The other died at age 5. Sharon obtained the copies at the LDS History

Library in New Berlin, WI. [Now Bob also has a new location where he can do cemetery related research.]

### **Cemeteries & Superstition**

In many countries, cemeteries are objects of superstition and legend; they are sometimes used (usually at night-time) for black magic ceremonies or similar clandestine happenings. In Haiti the traditional belief regarding zombies as practiced under "Voudun" religion is connected with burial rituals. It is believed that the zombified individual is buried alive in a coffin in a shallow grave after being given a dosage of tetrodotoxin from the puffer fish to slow his heart so he appears dead even to medical practitioners.

After all the burial ceremonies are completed the zombie victim is then dug up and taken into servitude, usually as a punishment for some crime he committed. Some Haitians deny that these practices exist and that these kinds of voodoo practices are pure superstition.

### **MAY – MONTH END (Finance)**

#### **Balance Sheet**

- Cash decreased \$20,233 for the month of May. The largest payment was a down payment
- of \$46,000 to Dillett for the three new HVAC units.
- Current Liabilities increased by only \$7,035.

#### Income Statement

- Revenue for May was favorable to budget by \$5,794. Y-T-D came in favorable to the budget by \$188,611. As stated last month, \$61,600 was from the PPP loan and \$70,000

in one time donations.

- Expenses continue to be in control at \$6,657 favorable to budget for the month of May.
- Y-T-D expenses without the \$1,655,335 loss on the sale of St. Mary's property iis \$570,576 or \$37,291 favorable to budget.
- Net Income was favorable to the budget by \$12,451 for the month of May. Y-T-D came in at \$232,917 or \$225,902 favorable to budget. Keep in mind that \$61,600 was from the PPP loan forgiveness.
