An important thing to note upon to do lay witness viewing is that the "Other Income and Expenses" appears as a negative number. This is part of accounting testimonial methodology in regards to interest income. This is actually a positive amount. Do not be alarmed, we are in good shape. There has been a dramatic change with regards to Buildings and Grounds Expenses. We recently replaced the stairs at the St. Mary's cemetery. The roof of the church is leaking after the major rain we had and will need repair. Our buildings are 25 years old and the need for repair is anticipated. Church revenue is down, mostly due to demographic changes in our population. We recently received an 8k donation and a 2k donation. We recently received 30k from the Archdiocese for the Love One Another (LOA) campaign. We have received a total of 200k so far. Soon, the organ will be removed and the floor underneath replaced. This will be the start of changes parishioners will start to see with the LOA funds. We will also have the ability to do some future planning / building, as we are in need of meeting, classroom, and storage space. A company is interested in taking our organ at no cost to us, other than the volunteers that will be needed to help disassemble. Trustee (Dale) comments: Dale is working with a small AV group to implement improvements to our system. Dale will give a general update to the parish regarding the LOA during all masses soon. He is very happy with our progress. **General Items Communion procedure for music ministers:** New graceful procedures are needed for each Mass. Discuss with Confusion over "Commission" vs. "Committee": These are two terms that mean the same thing. At Grace and P&W QoA we chose to use the word "commission" years ago and look to be consistent in using that term. "Committee" could be used to designate a smaller group task under a commission ie: AV committee or
