In Paragraph C, Remove "Parish members 17 years of age or over and confirmed may vote on printed ballots for" and replace with "the Pastor will select by drawing" and Remove "garnering the most votes" and replace with "selected by drawing".

Liturgy Commission: No representatives were here, so no report was given. Discussion of having one of the newly selected members to be a council representative to the Liturgy Commission.
