Debt Reduction has 24,000 in fund.

Faith Formation accounting shows books and materials. Subsidy for Faith Formation is \$25,000. Parish Picnic Fundraiser was a profit of \$11,000.

Renaissance Restricted funds thru August is \$64,174. Need to pay parish back \$98,409 for school demolition. There should be a Renaissance envelope monthly in our packet of parish envelopes. At this time the envelopes are still every other month. Steve Siegel will check on this issue.
