Renaissance Restricted funds thru September is \$69,774. Need to pay parish back \$98,409 for school demolition.

One by One fund raiser thru the diocese collected to date is \$82,000. This amount is accumulating interest.

Contributing parish units is 225. Compared to 230 in 2021.
