Because no one knows where we will be in the journey of the pandemic in August of 2021, we are requiring parents to make a decision upon registering about whether they are opting for in-person or virtual learning for their children. After all, we could very well still be operating in Plan B in August. Of course, if social distancing is no longer required, we will welcome all students back to learn in person.

Tuition and Fees 2021-2022 - St. Ann Catholic School

Registration Fee: \$175 per new family
 \$125 per returning family if paid by March 1 (After March 1, returning families must pay the new family fee.)

Instructional Fee: \$250 per child (Grades K – 8th) - Due May 3 (may be paid during registration)
 \$200 per child (Pre-K) – Due May 3 (may be paid during registration)

Our primary goal is to offer a quality Catholic education at an affordable rate. The cost of education, however, is affected by the rising cost of textbooks, supplies, utilities, etc. Everything is affected by the number of students we enroll. The charts below list your tuition fee based on your church affiliation and the number of children from your family enrolled at St. Ann.

Tuition Rate: Pre-K: \$4,800

We offer one rate for our Pre-K class.

Tuition: Kindergarten – 8th Grade:

Members of St. Ann Catholic Parish or other local Catholic parishes: (A signed verification form is required from the office of your Pastor and **must be submitted within 5 days of registration.**)

*** Eligibility for the "participating" Catholic rate is determined by the Pastor/Pastoral Administrator. In determining eligibility, the student and/or family must:

1. Be baptized as a Catholic,
2. Be registered in the parish and
3. Attend Mass regularly and contribute financially to the support of the church through envelopes.

Families with 4 or more children should discuss tuition fees directly with the Principal.

North Carolina Opportunity Scholarship Grants: Parents whose children are recipients of the **North Carolina Opportunity Scholarship Grants** should be prepared to pay both the registration fee and the instructional fee for each child. A \$500 per student tuition charge will also be assessed.

Payment Plans

Annual: Full payment paid directly to school on or before **June 1**.

Bi-Annual: Two payments paid directly to the school on or before **June 1** and December 1.

Monthly: FACTS Tuition Management - You have the capability to set up your account for twelve (12) monthly payments starting in June through May using FACTS Tuition Management. Apply online through factsmgt.com. There is a \$45 application fee for enrollment.

Tuition Assistance

FACTS Grant and Aid Application: Any parents unable to meet these payments and who desire a Catholic education for their children may complete the Grant and Aid Application online at factsmgt.com. Neither the Pastor nor Principal want to turn anyone away from St. Ann Catholic School if they meet the requirements. Please note that priority for tuition assistance is given to active members of St. Ann Catholic Church. Application for assistance must be made prior to March 1st before the academic year of enrollment. A \$35 application fee is required.

AAMEN & God's Work Our Challenge Awards: These funds are awarded through the Diocese of Raleigh. To be considered for either of these awards, you MUST complete the FACTS Grant and Aid Application by the March 1, 2021, deadline in addition to completing the award application.

Misc. Information

Families who apply for admission after the school year begins will be assessed tuition fees on a pro-rated basis.

St. Ann Catholic Church rosters are checked twice each year to determine the level of involvement of those claiming St. Ann as their parish. In order to continue receiving the Catholic rate, parishioners must show active financial involvement in the church and its functions.

All families are expected to volunteer at least 10 hours per year. If a family opts not to fulfill this requirement, a fee of \$100 will be assessed.

Kindergarten students will be screened in May prior to their entrance into the school. Families moving to the area at a later date will be scheduled at a time when the kindergarten teacher is available.

Should a family find it necessary to withdraw from St. Ann Catholic School prior to the end of the academic year, one month's tuition will be assessed. This requirement will be waived if written proof is provided that the withdrawal is the result of a geographical move caused by employment transfer.
