

Much, but not all, of the following content was also contained in a letter sent to our parishes' CPL participants:

Dear Parishioners,

I remember a year ago saying that 2019 had passed quickly. For many, 2020 cannot pass quickly enough. We are certainly thankful for the great commitment that has been shown to our extended Catholic family at Our Lady of Mercy and St. Brigid, in a year of unprecedented challenges. It has been a time that we have had to either be creative and flexible in the way that we preserve our faith, or let it go by the wayside altogether. As we transition into 2021—most likely with a subdued celebration—it is both a time of hope, as we prepare to have a new shepherd installed in our diocese, and a time of great concern at the parish level. Within the limits imposed and embraced due to the pandemic, we do our best to fortify our faith and invite others to this life of communion with Jesus Christ, while preserving the tremendous heritage of our communities.

We are especially grateful for the many sacrifices you have made to support our parishes—especially at a time that so many are struggling. With the Sunday and Holy Day Obligations being dispensed, and so many lives thrust into economic uncertainty, many have put their parish life on the back burner. Others have maintained, to the best of their ability, their religious routine with the help of the electronic media. To meet our weekly and monthly expenses, your generosity has been critical to providing a sustained income stream. Through much of the pandemic, we have struggled through the drop in income, as well as *new expenses* due to COVID-19 such as streaming and sanitizing. We can say that because of your kindness and the Federal PPP Loans, our two parishes weathered much of the storm better than many parishes in our local church. However, in recent weeks, in both of our parishes we are feeling the pinch more profoundly. The more we are able to pay our weekly and monthly bills from our collection, the less we will have to dip into the savings—which has been a lifeline in 2020—but will not last forever.

There are three main ways to support your parish financially:

- Electronic Fund Transfer,
- Online Giving by *WeShare* through our parish website (and its companion *TEXT-TO-GIVE*), or
- The traditional envelopes which many have continued using either by USPS or by dropping them off in

one of the three secure drop boxes in the Church or the box at the parish center entrance.

If you choose to contribute via an electronic fund transfer, we are required to have a yearly signed authorization form, please fill out the appropriate form (inserted in this bulletin) and return to the office.

You may wish to consider the secure and easy-to-use Online Giving by *WeShare*. This gives you great access and control in your giving, as well as the opportunity to target you donations to special projects that arise. In addition, our friends at LPI offer unprecedented customer support.

Thank you for the support concern that you have also shown toward our staff and the Mercedarian Community. Know that you are in our prayers. Merry Christmas and Happy New Year. Let us continue to pray for one another.

PLEASE TAKE NOTICE THAT, On February 28, 2020, The Diocese of Buffalo N.Y., (“Diocese”) filed for protection under chapter 11 of title 11 of the United States Code (the “Bankruptcy Code”).

The Bankruptcy Court has established August 14, 2021 at 11:59 p.m. (prevailing Eastern time) as the deadline to file proofs of claim against the Diocese (the “Bar Date”).

If you have a claim against the Diocese, including, without limitation, a claim related to sexual abuse committed by any person connected with the Diocese, you must file a claim on or before the Bar Date.




