Dear Parent or Guardian,

We are pleased to offer students in St. Mary's School of Religion access to the St. Mary's Church computer network with internet access as a tool for educational purposes only. To obtain internet access, all students must obtain parental permission and must sign and return this form to the school office. However, access is a privilege, not a right, and carries with it responsibilities for all involved. A user who violates this agreement shall, at a minimum, have his or her access to the network and Internet terminated.

Students may use their personal electronic mail accounts and use collaborative tools (cell phones, ipads, laptops, blogs) to share their work. It is expected that users will act in a considerate and responsible manner when accessing network services. Administration reserves the right to monitor, inspect, copy, review and store at any time and without prior notice any and all usage of the computer network and Internet access and any and all information transmitted or received in connection with such usage.

The following are not permitted:

- Sending or displaying offensive messages or pictures
- Using obscene language
- Harassing, insulting, or attacking others
- Violating copyright laws
- Trespassing in another's folders, work or files
- Deliberate damage to hardware or software
- Illegal activities
- Using or changing another's password
