1.- **New Construction in progress:** Mapping of the property was completed / The Santa Cruz County Community Development Commission granted the rezoning of the property as commercial allowing the new construction of the church / CMG conducted they hydrology study and prepared their report which allow the civil engineer design drawing / The landscape design drawing was completed / The coordination of the dry utilities was completed evaluating existing infrastructure and planning for future needs / The Architect has submitted his development plan for review by the SC County Community Development office in September 2025.

**2.- Capital Campaign:** The total pledges raised for our capital campaign was \$227,880 the total collected from this pledges as of June 30, 2025 is \$115,083

3.- The total Capital Campaign and Parish Pooled investment as of ending June 30, 2025 is \$ 4,504,492.98
