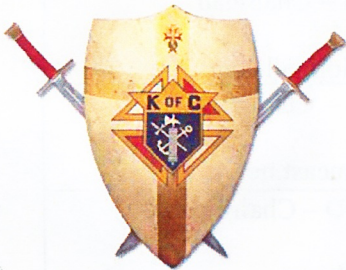
## DINNER MEETING AGENDA
