TUITION PAYMENT PLANS

Registration Fee:

A non-refundable registration fee of **\$100.00 is required** for each student in PK-8. The fee is due at the time of registration. Late registration fees will be assessed after specific dates. Registration is not complete until your \$100 fee has been paid.

K-8 Total registration fees: \$350 (*The \$100 fee at the time of registration will be applied to this amount, and the remaining \$250 will be added to the tuition agreement.*)

PAYMENT OPTIONS

Option 1: Payment in Full - Full payment of tuition and fees is due by August 1st. Payment can be made by check or through FACTS. All families must have a FACTS account to attend St. Cecilia School. FACTS will charge an annual processing fee. **All tuition payments and fees are nonrefundable.**

Option 2: Monthly Payments - Twelve (12) equal tuition payments* begin in July, which **MUST BE PAID THROUGH FACTS**, and end in June the following year. All families must have a FACTS account to attend St. Cecilia School. FACTS will charge an annual processing fee. **All tuition payments and fees are nonrefundable.**

You may select the **5th or the **20th** of the month for your payment date.*
