TUITION ASSISTANCE PROGRAM

While a Catholic education yields great rewards, it requires sacrifice for most families. For families of modest means, particularly those with multiple children in school, a Catholic education may be unaffordable without help.

St. Gregory the Great Parish is pleased to provide a Tuition Assistance Program to help families in need. The program is available to parents who currently have students enrolled at St. Gregory the Great School or would like to choose St. Gregory the Great as the school for their children.

The Tuition Assistance Program is based solely on financial need rather than academic merit. Funds are limited and families are expected to pay part of the tuition. The program is not designed to address situations involving late payments or default of payment. St. Gregory the Great Parish's Tuition Assistance Program is not related to the Wisconsin private school tuition loan program.

To qualify for assistance, families:

- Must be registered parish members.
- Must have completed the 2018 Financial Stewardship Commitment
- Must have completed 2019-20 school registration with \$150 deposit

The application procedure is as follows:

- Complete all school registration paperwork. Complete the attached Tuition Scholarship Application form and supply the requested information – **your most recent Federal Income Tax report must accompany the application.**
- Return materials by May 1st to apply for assistance. Return materials to the school office in a sealed envelope to maintain confidentiality.
- The school office will forward the envelope containing your materials to the review team. The review team is composed of parish members who have a significant interest in our school, but do not have children enrolled.
- The review team determines a family's eligibility based on an analysis of the family's income as well as other factors that affect ability to afford tuition.
- Upon completion of the review, the review team will send a recommendation to the pastor. Families will be notified of the decision made regarding their request for assistance by the first week of June.
