SKYLINE Students who park on Mary, Queen of Peace Catholic Church property for the purpose of school commuting, must have a valid MQP Student Parking Permit. Students will be assigned a **specific parking stall** that coincides with the permit number. Space is limited and available on a first-come, first-served basis. In exchange for the parking privilege, **Skyline Students** agree to: 1) a donation to MQP (the donation helps fund the patrolling of our parking lot and the administrative support needed for this parking program) and 2) provide **1 hours of community service** through Mary, Queen of Peace. **Community Service hours are due no later than June 4, 2021**

2. Donation (checks made payable to MQP) must be submitted with application
3. Agreement and Waiver forms must be signed and attached.

Mary, Queen of Peace Catholic Church Skyline High School Student Parking Regulations

What is Student Parking?

Mary, Queen of Peace welcomes the opportunity to share its facilities with the community. We are, therefore, pleased to offer Skyline High School students the privilege of parking at Mary, Queen of Peace for school commuting.

Skyline students, who wish to park at Mary, Queen of Peace for school commuting purposes, must apply in person (NO PARENTS) for a MQP Student Parking Permit.

Permits are available for fall and spring semesters. An application is required for **each semester**. Students who are issued a Parking Permit are required to provide **1 hour** of community service through Mary, Queen of Peace per semester. **Spring service hours must be completed by June 4, 2021.**

Beginning **April 13, 2021** applications for parking permits will be accepted in the Church Office (1121 228th AVE SE, Sammamish) during normal office hours (Mon - Fri; 10:00 a.m. - 4:30 p.m.) **All required information and supporting documents must be submitted with the application. Applications that are missing required documentation will be returned to the student for completion and must be turned in before a parking permit is issued.**

MQP STUDENT PARKING POLICIES:

- Student must maintain **current** information on file with MQP. Changes must be submitted, **in writing within 1 week**, to the Mary, Queen of Peace office (i.e.- change of car; change in personal information or insurance provider).
- **Each Permit assigns a specific vehicle to a specific parking stall. Students may not provide their Parking Permit to another student..**
- Parking Permit grants students the privilege to park in the Mary, Queen of Peace parking lot in the **student parking area** (see map—available in the church office) during school hours.
- MQP Student Parking Permit **must be placed on the lower left side of the front window shield** of the car. If it is not clearly visible, a warning will be issued. Repeat violators may have their car towed at the owner's expense and forfeiture of parking privileges.
- If the license number of the car does not match the license number of the permit, a warning will be issued. Repeat violators may have their car towed at the owner's expense and forfeiture of parking privileges.
- Students may park **only** in their assigned parking stall. Parking anywhere else on the Mary, Queen of Peace lot will result in a warning. Repeat violations will result in the forfeiture of parking privileges at the church and the student maybe declared ineligible for parking on the Skyline campus **for the remainder of their time at Skyline High School.**
- Students assume responsibility for keeping the area around their vehicle clean. Any paper, restaurant or food debris found near their vehicle will be considered a **first offense**. (Note: All cars parked **near** the debris will be tagged with a warning.) A **second offense** may result in the revocation of the MQP Student Parking Permit and/or towing of the vehicle at the owner's expense. Failure of students to clean up the area(s) around their vehicle may result in the closing of the entire parking lot for one week per incident.
- Mary, Queen of Peace does not assume responsibility for property theft or damage to vehicles. Student must report theft, accident, or vandalism to local law enforcement authorities and the church.
- Lost permits may be replaced for \$5. A lost permit must be reported to the MQP Office without delay.

- Church officials are neither qualified nor trained to assist students in gaining access to their car or in its maintenance.
- Mary, Queen of Peace reserves the right to temporarily suspend parking privileges when a church event requires full use of the parking lot. Should such an occasion arise, MQP either place a written notice on the windshield of student automobiles in advance or send an email.

DRIVING ON OR ABOUT MARY, QUEEN OF PEACE PROPERTY:

- Obey all Washington State traffic laws; failure to do so may result in immediate revocation of the MQP Student Parking Permit.
- The speed limit in the church parking lot is **10 MPH** and will be strictly enforced.
- Obey all entrance, exit and directional markings.
- NO walking on the in or out driveways
- ALWAYS use the crosswalks
- Speeding, reckless driving, or endangerment in the MQP parking lot or on adjacent streets may result in revocation of the MQP Parking Permit and citation by local law enforcement authorities.
- Parking without the assigned MQP Student Parking Permit is subject to towing at the owner's expense and forfeiture of parking privileges.
- Violation of these rules will result in a student warning, possible revocation of permit and/or towing of vehicle at the owner's expense.

COMMUNITY SERVICE HOURS MAY BE COMPLETED THROUGH ONE OF THE FOLLOWING OPTIONS:

- One of a few group options on the green card or to be announced by email;
- A community service project approved by staff of Mary, Queen of Peace. If you are unable to attend a group project, **IT IS YOUR RESPONSIBILITY TO SCHEDULE AND COMPLETE YOUR OWN SERVICE PROJECT HOURS** with a staff member of Mary, Queen of Peace. This must be done independent of other class/extracurricular requirements (i.e. National Honor Society or Key Club). **Spring hours are due no later than June 4, 2021.**

CONSEQUENCES OF MISUSE OR ABUSE OF MQP PARKING PRIVILEGES:

AS PREVIOUSLY STATED, THE POTENTIAL CONSEQUENCES FOR VIOLATION OF THE RULES ESTABLISHED BY THIS AGREEMENT INCLUDE THE REVOCATION OF YOUR PARKING PERMIT, REVOCATION OF ANY FUTURE PARKING PRIVILEGES AT EITHER MARY, QUEEN OF PEACE OR SKYLINE HIGH SCHOOL, TOWING OF YOUR VEHICLE AT YOUR EXPENSE, AND A CITATION ISSUED BY THE SAMMAMISH POLICE DEPARTMENT. IN OTHER WORDS, THE CONGREGATION IS HAPPY TO SHARE THE LOT WITH YOU, BUT, THIS IS A PRIVILEGE, WHICH, IF ABUSED, HAS SERIOUS CONSEQUENCES.

Student Parking Permit Agreement

If any portion of the **Release** is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
