Nursery COVID POLICIES

As of February 1, 2021

- Parents will sign-in/out right inside the nursery door at the counter. A cup for used pens will be provided. Due to the need to social distance inside the nursery and the small space, parents are asked that only ONE person from the family enters to drop-off or pick-up children. Please do not linger or stay long.
- Temperatures will be taken upon entering the nursery. These will be taken by a Nursery Caregiver at the door. Temperatures must not exceed 99.9.
- Caregivers will ask parents screening questions regarding the child entering the nursery using the Nursery Covid Screening Questionnaire.
- Caregivers will make a visual inspection of the child for signs of illness which could include flushed cheeks, rapid breathing or difficulty breathing (without recent physical activity), fatigue, extreme fussiness, coughing, or runny nose.
- Masks will be worn by nursery caregivers and volunteers at all times. *Masks are not required to be worn by children age 5 and under.*
- Alternate ratios will be upheld during the pandemic. The ratio will be 3 children for every (1) caregiver. A total of 9 children (with 3 caregivers) is our max capacity.
- Handwashing and hand sanitizing will continue as per our regular nursery policies and happen frequently by Nursery Caregivers, volunteers, and children in care.
- Toys will be placed in a sanitizing bin after a child has used it. These toys will be sanitized between use.
- As always, we will clean and disinfect between each shift and as needed during each shift. Extra precautions will be taken for Covid measures.
