Parking in the Mass Avenue area is at a premium. There is an additional public, pay lot north of the Church on Vermont St. St. Mary offers limited parking for your wedding, on a "first come, first served" basis. It is available for your use **during your wedding rehearsal and wedding ceremony**. St. Mary has Masses and other activities on weekends; so, your guests **should not assume that they may leave their cars here at other times**. Additional use, outside of the rehearsal and wedding ceremony are only by special arrangement with our Facilities Coordinator, Francisco Ruiz (317-627-9349). **Unauthorized cars may be towed at the owner's expense.**

We are responsible for basic cleaning up after the wedding (personal items, decorations, etc). We understand that we are responsible for any damages that our guests or we may cause to the church and/or grounds.*
