Legislative update w/ Don Parker

New bill is being presented: House Omnibus Health Bill (HF2930)

- Extremely radical
 - Takes all of the wish list of the democrats and pro-abortion people on the house health committee and rolls it all into one bill
 - o All of the repeals as other bill HF91
 - Also adds elimination of the funding for pregnancy resource centers, like Positive Alternatives Grant funding
 - MCCL has asked pregnancy resource centers and their stakeholders to advocate for themselves by writing to governor & legislators to come visit the care centers and see the good work that is being done there.
 - Some legislators have done this and have been impressed
 - In HF91, we worried about the elimination of the law that said if a baby survives an abortion, that baby would need to be treated to try to save their life/health
 - In HF2930, the threat to life/health of newborn babies is not limited to babies that survive abortion; it is expanded to ANY and ALL newborn babies.
 - Particularly threatening to disabled children born
 - MCCL has been doing a lot of work against 1st version and 2nd version of that bill to make it fully unacceptable to legislators
 - There has been pushback, mostly from doctors who want to be able to make that choice without anyone looking over their shoulders
 - Healthcare cost containment commission is another part of this new bill
 - People mostly appointed by the governor would have the power to tell healthcare entities how much of an increase in spending they could have.
 - This would put tremendous pressure on these entities to keep spending down
 - Could cut costs by not treating/providing care to the elderly, disabled people, and people with chronic illnesses
 - EVEN IF THE MONEY IS PAID FOR BY INSURANCE OR OUT OF POCKET
- Senate has its own Omnibus Health Bill
 - As it exists now, Senate bill does not have any of this new nonsense.

- Only pro-abortion thing the Senate omnibus health bill has is a 10% increase in reimbursement for Medicaid to pay for family planning and abortion.
 - Not good, but won't threaten lives directly near as much as the House bill
- IF there are senators who will not accept the radical bill (only takes one undecided/pro-abortion senator to not accept it), then they will have to deal with the Senate bill
- Unfortunately, it's somewhat likely that the House will pass their extreme bill first, and the radical leadership in the Senate can take up the HF2930 House bill and move it up to the Senate.
- What can we do?
 - We need to FLOOD legislators with communication and build up a public complaint/unacceptance of these bills - we need to make our unacceptance loud and clear to the legislature / governor's office.
 - Go to town hall meetings
