
Three Steps to Changing a Life

STEP 1: HOW MUCH CAN I CONTRIBUTE?


Take a quick look at last year's AZ state tax return. If you file Form 140, look at LINE 48 to find the amount that you can contribute. If you file Form 140PY, look at LINE 58. Still not sure? Visit our website. The contribution limits for 2020 are \$1,183 for single filers, and \$2,365 for married couples, filing jointly.

STEP 2: MAKE YOUR CONTRIBUTION

Choose the General Scholarship Fund, which serves the schools in most need, or designate the school(s) of your choice.

- **Mail:** Complete and mail the contribution form.

STEP 3: CLAIM YOUR TAX CREDIT USING AZ TAX FORMS 323 AND/OR 348 ON YOUR 2020 AZ TAX FILING

CEA will mail you a tax receipt as proof of payment. Present this to your tax preparer (or use with your personal tax software). Result: you just directed your tax dollars to a student who needs your help!

NO QCO CODE NEEDED!

What is the private education tax credit?

Arizona law (ARS43-1089) allows a taxpayer to direct all or a portion of their state tax liability to certified School Tuition Organizations (STOs) such as Catholic Education Arizona. Your tax credit dollars are used exclusively for tuition scholarships for under-served children enrolled in Catholic Schools within the Diocese of Phoenix.

How do I know if I pay income taxes?

Look at your last Arizona state tax return to determine about how much you pay in state income taxes. Check line 48 on Tax Form 140, or line 58 on Tax Form 140PY. The amount found on these lines is your Arizona state tax liability. This amount will give you an idea as to what you can direct to Catholic Education Arizona this year, up to the maximum tax credit amount allowed by law (\$1,183 Single Filer and \$2,365 Joint Filers.)

Did you know that you can DOUBLE or even TRIPLE the impact of your tax credit contribution at no additional cost to you? And it's easy to do!

Many employers sponsor matching gift programs that match tax credit contributions made by their employees and retirees. By simply completing a matching gift form provided by your employer, you may be able to have your contribution matched. To see if your employer participates, visit our Matching Gift Opportunities page on our website.

Can I take multiple tax credits (private education, public school, qualifying charitable, foster care)?

Absolutely! You can participate in multiple tax credit programs up to the extent of your state tax liability. Remember, if you end up contributing more than your tax liability this year, you can carryover the excess for up to 5 tax years.
